We respect your right to privacy and want our clients to be aware of any information we collect, how we use it, and under what circumstances, if any, we disclose it. This statement applies to information collected on the web site as well as for purposes of completing service requests. Information Collected:

We collect the following types of information from our web site and application:

a) Non-personal Data/Aggregate Info

In order to evaluate which information we provide is used, how many visitors we receive, and how we might improve our services, the Console & OTG4U collects and analyzes web site visitor information. We track information such as Internet (IP) address, browser type, date/time of visit and which pages visited. Personal information, such as your name and email address are not collected in this process. We use this information only to gather demographic data about our user base as a whole. We will only disclose this information in aggregate form. For example, we might disclose that a certain percentage of our viewers use our web site on Saturday. We do not link this automatically-collected data to personally identifiable information.

b) User Information/Registration

Users are requested to register for various Console & OTG4U services. You are under no obligation to provide this information, but without it, we may be unable to provide you with these services. The registration information enables us to contact you regarding our services. For example, based on the registration information you provide, we may send you a welcome email to verify your email address, username and password. In order to provide you with the highest level of customer service, we may send you details of our products and services which we think may be of interest to you.
