By accessing or using the Application, you agree to these terms of use, conditions and all applicable laws. If you do not agree to these terms do not purchase the product.**

## **1. LICENSE; RESTRICTIONS ON USE**

1.1 You are granted a nonexclusive, nontransferable, limited license to access and use the Concierge Console™ and its Materials & Data per the terms of the period of use of your purchase agreement. This license includes:

- (a) The right to electronically display Materials & Data retrieved from the Application to no more than the registered users, subject to the Supplemental Terms for Specific Materials & Data;

3.2 Except as otherwise provided in section 3.1, the Application and Materials & Data are provided on an "as is", "as available" basis and the provider of the application and each third party supplier of materials & data expressly disclaim all warranties, including the warranties of merchantability and fitness for a particular purpose.

### **4. LIMITATION OF LIABILITY**

4.1 A Covered Party (as defined below) shall not be liable for any loss, injury, claim, liability, or damage of any kind resulting in any way from (a) any errors in or omissions from the Application or any Materials & Data available or not included therein, (b) the unavailability or interruption of the Application or any features thereof or any Materials & Data, (c) your use of the Application or Materials & Data (regardless of whether you received any assistance from a Covered Party in using the Application), (d) your use of any equipment in connection with the Application, (e) the content of Materials & Data, or (f) any delay or failure in performance beyond the reasonable control of a Covered Party.

4.2 "Covered Party" means (a) the provider of the Application, its affiliates, and any officer, director, employee, subcontractor, agent, successor, or assign of the provider of the Application or its affiliates; and (b) each third party supplier of Materials & Data, their affiliates, and any officer, director, employee, subcontractor, agent, successor, or assign of any third party supplier of Materials & Data or any of their affiliates.

5.4 The failure of the provider of the Application or any third party supplier of Materials & Data to enforce any provision hereof shall not constitute or be construed as a waiver of such provision or of the right to enforce it at a later time.

5.5 The subscribing organization or individual may not assign its rights or delegate its duties under the subscription to access the Application without the prior written consent of the provider of the Application.
